Job description	The successful candidate will provide, under the supervision of the project PI, expertise in data mining, data analysis as applied to risk assessment of vector-borne and zoonotic diseases and will collaborate on the development and implementation of innovative approaches in data mining and data analysis, to achieve the tasks assigned to FEM by the EU Horizon 2020 project MOOD (specifically Workpackage 2; Tasks 2).
